Keeping to the timetable

If you do not send us the relevant documents in time, the Inspector will not normally look at them and we will return them to you. You



must note the details of the following timetable because we will not send any reminders.

The following documents must be sent within this timetable.

By 3 June 2009

Please can you notify any statutory parties and interested persons, who were consulted previously on both applications/appeals, that the inquiry into appeal reference APP/A5840/A/09/2104387 (formerly APP/A5840/A/05/11844270) will be re-opened and the appeal will be re-determined. Please also mention that it will be heard jointly with appeal APP/A5840/A/08/2063340 which is being restarted after a period of abeyance. You should tell them that:-

- i) if they want to make any additional comments, they must submit 3 copies within **6 weeks of the date of this letter**. If representations are submitted after the deadline, they will not normally be seen by the Inspector and will be returned.
- ii) they can get a copy of our booklet 'Guide to taking part in planning appeals' free of charge from you, and
- iii) if they want to receive a copy of the decision(s) they must write to me requesting one.

Please can you forward a copy of your notification letter and a list of those notified to me.

By 1 July 2009

Please send me 2 copies of your statement(s). I will send a copy/copies of your statement(s) to the appellant and send you a copy/copies of their statement(s). I will send you and the appellant a copy of any comments I receive from other interested parties or organisations.

By 22 July 2009

You and the appellant must submit 2 copies of any final comments you and they have on each other's statement(s) and on any comments from interested people or organisations. You must not send your final comments instead of, or to add to your statement(s). No new evidence is allowed at this stage. I will send you a copy of the appellant's final comments at the appropriate time.

Using e-mail or post

If you send us your documents by e-mail, you only need to send us one copy of each. However, if you post your documents, please send us **2 copies** of everything and put the full appeal reference number on each copy.

No later than 4 weeks before the inquiry

You and the appellant must send 2 copies of your proofs of evidence (and summary where appropriate) to me. You must also send a copy of the agreed statement(s) of common ground.

If you propose to give, or call another person(s) to give evidence at the inquiry, you must also send us in writing an estimate of the time required to present all their evidence and confirmation of the number of witnesses you intend to call.
